## **Respirator Fit Testing**

Northwest Insurance Agency's in house risk management team will be providing the required annual fit testing for full face and half masks cartridge respirators, as well as the N95/N100 dust masks. Each type of respirator requires a different test. Please provide mask type with completed form prior to testing.

#### Cal/OSHA Respiratory Standard:

Please remind employees that in accordance with  $\underline{\text{Cal/OSHA 5144(g)(1)(A)}}$  the employer shall not permit respirators with tight-fitting face pieces to be worn by employees who have facial hair that comes between the sealing surface of the face piece, or that interferes with valve function.

Medical evaluations shall be conducted prior to the employees fit test. Medical evaluations can be conducted at your local occupational health clinic, or online with the <u>3M Online Respirator Medical Evaluation Tool.</u> **Medical evaluations will not be available or performed at this event.**
