## **Sexual Harassment Prevention Training**

MVP Safety is providing the required Sexual Harassment Prevention Training, 2-hours for Supervisors and the 1-hour for Employee/Non-supervisor.

## Who's employees need the training?

California employers with 5 or more employees are required by law to provide two hours of sexual harassment and abusive conduct prevention training to all supervisors and one hour of such training to nonsupervisory employees once every two years and within six months of hire or promotion. Both supervisory and nonsupervisory employees were required to have this training by January 2021 and every two years thereafter. Seasonal and temporary employees must receive training within the first 30 days or 100 hours.
