Sexual Harassment Prevention Training

MVP Safety is providing the required Sexual Harassment Prevention Training, 2-hours for Supervisors and the 1-hour for Employee/Non-supervisor.

Who's employees need the training?

California Civil Rights Department (CRD) requires that employers with 5 or more employees provide two hours of sexual harassment and abusive conduct prevention training to all supervisors and one hour of such training to nonsupervisory employees once every two years (once a year for FLC's and their supervisors). For employees hired for less than six months, employers are required to provide training within 30 calendar days after the hire date or within 100 hours worked, whichever occurs first.
